- e. Delete paragraph 1228. Insert new paragraph 1228.
 - "1228. AFV Form 1 and MACV Forms 333 and 334 are accountable documents and are to be controlled as follows:
 - a. AFV Ration Card Control Officer. Staff Captain Q HQ AFV is appointed AFV Ration Card Control Officer. He is responsible for:
 - (1) Obtaining bulk stocks of cards.
 - (2) Custody of bulk stocks.
 - (3) Issuing in bulk to area ration card control officers.
 - (4) Maintaining records of issues and receipts.
 - b. Area Ration Card Control Officers. 1 ATF, 1 ALSG and HQ Coy HQ AFV are to appoint an officer who is responsible for:
 - (1) Demanding bulk supplies, by signal, on the AFV Ration Card Control Officer.
 - (2) Receipt, secure storage and issue in bulk to administered units.
 - (3) Maintaining records of issues and receipts.
 - (4) For HQ Coy HQ AFV, direct issues to authorized personnel.
 - c. Unit Ration Card Control Officers. Units are to appoint an officer who is responsible for:
 - (1) Obtaining bulk supply of cards from Area Ration Card Control Officers as required.
 - (2) Receipt, secure storage and issue to authorised personnel.

1228A. HQ AFV is to be advised of the Area Ration Card Control Officers appointed. Where there is a change of incumbents, a handover of accountable documents is to be carried out in accordance with Equipment Instructions, Part , Paragraph 1270.

V53. 1 ATF ELECTRICAL SCALES.

General.

- 1. This instruction lays down the electrical scales for tents and accommodation buildings in 1 ATF Area. These scales are not to be exceeded without approval of DCRE 198 Works Section.
- 2. Electrical wiring is only to be carried out by authorised RAE tradesman. No electrical equipment is to be indented for, locally

purchased or connected to 1 ATF electrical reticulation without the approval of the DCRE. Double adaptors are not to be used in general power outlets.

3. Out of scale and unsafe wiring is to be removed when located. Technical assistance may be requested from 198 Works Section or 21 Engr Sp Tp. It is a unit responsibility to ensure no illegal electrical wiring is installed and to take disciplinary action against offenders.

Tent Lighting.

- 4. Tent lighting is to be wired in flexible cable, double insulated, and is to be connected to the circuit via a 3 pin plug and waterproof ironclad 3 pin socket. The cable is to be firmly fixed to the tent pole on entry into the tent.
- 5. The lighting in accommodation tent lines is restricted to 60 watts per tent. The tent lampholder is to consist of one only switched BC cord grip lampholder. Where a lampholder is fitted with an improvised light shade the lamp is to be 60 watts and the shade perforated. An approved light adaptor may be used in lampholders which are not fitted with an improvised light shade. The adpator is to be a two way, one way switched.
- 6. The only appliances to be used with a lampholder and light adaptor are electric razors, tape recorders, radios and fans. If these appliances are used they must be of the double insulated type not normally requiring an earth connection. (Generally speaking these are appliances having a non metallic casing.)
- 7. Subject to special approval by DCRH 1 ATF a tent may be provided with a general purpose outlet.

V54. CARE IN THE USE OF LIGHTBURN WASHING MACHINES.

- 1. In order to reduce the high incidence of unservicability in spin dryers sub-write are to cusure that the following provotions are observed:
 - a. Spin dryers are to be loaded by dropping clothing loosely into the drum before setting it in motion. On no account are clothes to be packed tightly into dryers.
 - b. If the overload switch operates causing spin dryers to stop, portion of the load is to be removed before switch is reset. Should the switch again operate on restarting the dryer is not to be reset, and the fault reported so that repair action can be taken.
 - c. Clothing is a t to be rinsed by pouring buckets of water into the dryer whilst it is in motion.
 - d. When the dryer is switched off it is to be allowed to come to rest without artifical braking being applied.
